**Course policies:** Lecture material will be posted on *Canvas* as the course proceeds. These will correspond to most, but not all, slides used during lectures; spoken lecture material will frequently present more explanation and detail. Exam material will draw upon lecture content and assigned reading; there will be two midterm and a final exams. Practice tests will be made available before each exam as an example of the test style and level of difficulty. Questions are welcome during and outside class time. Office hours will be immediately after lectures or by appointment. *Canvas* will be used for posting course material such as announcements, additional reading, practice tests, exam results and answer keys.

MB 434 grades will be based on the 3 exams, out of a total point score of 270; the class will be graded on a curve. MB 534 grades will be based on the same exams plus discussion and report contributions involving analysis of advanced topics covered in 5 additional class meetings (times to be arranged). Graduate students will be responsible for presenting and discussing two research papers.

Note the prerequisites and contact Dr. Dreher if you lack standard prerequisites but have other experience that makes you confident you are prepared to take the course.

#### **Learner Outcomes:**

At the completion of the course, you should:

1. be conversant with specialized language relevant to virology;
2. understand the basic design, infection and replication strategy of viruses, and the diseases they cause;
3. be able to communicate and explain in writing key aspects of virology;
4. be aware of currently exciting topics and issues in the field of virology.

#### **Learner Expectations** (advice for doing well in this course):

Intelligently and politely utilize the learning opportunities provided by lectures:

1. Attend all classes; do not arrive late or leave early
2. Prepare for the next lecture by reading or at least scanning handouts and assigned reading *before* class
3. Bring handouts to class and make notes on them during the lecture; you may record the lecture on a sound tape if you wish
4. Read over lecture notes and assigned reading in detail after class and *before* the next class; make notes on anything that is unclear or that you are curious about and seek an answer from the lecturer, a classmate or the text
5. Keep up in your understanding and reading; if you fall behind you will not be able to follow lecture material and will rapidly fall still further behind. Do not hesitate to consult lecturers to help you keep up and catch up.
6. You should allocate at least 2 hours of study for each hour lecture throughout the course; don't be tempted to rely on cramming.

- (i) CHEATING - use or attempted use of unauthorized materials, information or study aids, or an act of deceit by which a Student attempts to misrepresent mastery of academic effort or information. This includes but is not limited to unauthorized copying or collaboration on a test or assignment, using prohibited materials and texts, any misuse of an electronic device, or using any deceptive means to gain academic credit.
- (ii) FABRICATION - falsification or invention of any information including but not limited to falsifying research, inventing or exaggerating data, or listing incorrect or fictitious references.
- (iii) ASSISTING - helping another commit an act of academic dishonesty. This includes but is not limited to paying or bribing someone to acquire a test or assignment, changing someone's grades or academic records, taking a test/doing an assignment for someone else by any means, including misuse of an electronic device. It is a violation of Oregon state law to create and offer to sell part or all of an educational assignment to another person (ORS 165.114).
- (iv) TAMPERING - altering or interfering with evaluation instruments or documents.
- (v) PLAGIARISM - representing the words or ideas of another person or presenting someone else's words, ideas, artistry or data as one's own, or using one's own previously submitted work. Plagiarism includes but is not limited to copying another person's work (including unpublished material) without appropriate referencing, presenting someone else's opinions and theories as one's own, or working jointly on a project and then submitting it as one's own.
